COMPETITION RULES – ADVENTURE BASE AND LIFEJACKET TOUR DU MONT BLANC HIGHLIGHTS TREK

1. The “Competition” is open to all residents of all jurisdictions worldwide, unless where prohibited by local law. Employees of Adventure Base Ltd and LJSP Ltd are not eligible to enter.
2. No purchase necessary to enter or win. To enter, submit your email address into the box presented on the Competition page. The Competition will begin on the 6th of May 2026 and will end at end at 23:59 (GMT) 20th May 2026.
3. By entering the Competition, entrants consent to the collection, use and disclosure of their personal information for the purposes of administering the Competition and for the purposes of understanding the needs and preferences of individuals or to develop, enhance, market and/or provide products and services. For the purposes of this Competition, you consent that Adventure Base Ltd may collect, use and share personal information with its Competition Partner, LJSP Ltd. Both companies will treat your personal information in accordance with their privacy policies.
4. The Competition will be run in accordance with these rules, subject to amendment by Adventure Base Ltd (the “Rules”). Entrant must comply with the Rules and will be deemed to have received and understood the Rules by participating in the Competition. The terms of the Competition, as set out in the Rules, are not subject to amendment or counter-offer, except as set out herein. Adventure Base Ltd’s decisions with respect to the Competition are final and binding.
